Weekly Drill Series

Description: Westchester’s weekly drill series is designed to enhance the skillset of Fire Service personnel operating at a wide range of incident types. The drills will run one evening per week and rotate between four broad subject areas: Engine, Truck, Rescue/EMS, and Command/Leadership. The series is designed to supplement your department’s training schedule while providing attendees with proven drills they can bring back home. Each drill is purpose-built to benefit everyone, from the entry-level firefighter to the experienced chief officer. This weekly drill series will address many JPRs as outlined in OSHA 29 CFR 1910.120 and NYS Best Practices for Exterior Firefighters, Interior Firefighters, Driver Operators, Fire Officers, and Incident Commanders. The JPRs/ Standards include but are not limited to:

- NFPA 1001 – Standard for Fire Fighter Professional Qualifications
- NFPA 1006 – Standard for Technical Rescue Personnel Professional Qualifications
- NFPA 1010 – Standard for Firefighter, Fire Apparatus Driver/Operator
- NFPA 1020 – Standard for Fire Officer and Emergency Services Instructor Professional Qualifications
- NFPA 1021 – Standard for Fire Officer Professional Qualifications
- NFPA 1407 – Standard for Training Fire Service Rapid Intervention Crews
- NFPA 1408 – Standard for Training Fire Service Personnel in the Operation, Care, Use, and Maintenance of Thermal Imagers
- NFPA 1451 – Standard for a Fire and Emergency Service Vehicle Operations Training Program
- NFPA 1584 – Standard on the Rehabilitation Process for members during emergency operations and training exercises.
